# Detailed Judgment Schedule

**DETAILED JUDGMENT SCHEDULE  
Law and Order Ordinance  
Blue Lake Rancheria**

***Classification of Violations and Judgments***

(A) The following civil judgments shall apply to each violation:

- (1) Class C Violation civil judgment not to exceed \$250.
- (2) Class B Violation civil judgment not to exceed \$2,000.
- (3) Class A Violation civil judgment not to exceed \$5,000.

(B) Any person who commits a violation of the same class within ten (10) years from the date upon which a prior violation of the same class was committed may be subject to the following enhanced penalties:

- (1) A person who commits a Class C Violation three (3) times may be subject to a Class B civil judgment.
- (2) A person who commits a Class C Violation four (4) or more times may be subject to a Class A civil judgment.
- (3) A person who commits a Class B Violation three (3) or more times may be subject to a Class A civil judgment.
- (4) A person who commits a Class A Violation three (3) or more times may be subject exclusion.

(C) The following judgment schedule shall apply to all violations of Chapters 3, 4, 5, 6, 7, and 8 of the Law and Order Code, respectively, and shall be amended from time-to-time by the Tribal Council:
